IMPORTANT COMMUNICATION

FREE SCHOOL MEAL ENTITLEMENT

Every pupil in reception, year 1 and 2 is eligible for free school meals.

However, there are many families in our community who could be entitled to free school meals but are not registered to receive them. We need to make sure that our school receives all the government funding to which it is entitled — called pupil premium and worth approximately £1300 for each eligible child — so that we can provide your child with the best education and support.

It is important that we continue to register pupils who attract pupil premium regardless of whether or not they automatically receive infant free school meal entitlement.

If you receive one or more of the following benefits you are encouraged to register for free school meals as soon as possible:

- Income Support/Income Based Job Seekers Allowance (IBJSA)
- Income related Employment and Support Allowance (ESA)
- Support under part VI of the immigration and Asylum Act 1999
- Child Tax Credit (provided you are not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)

Note: Where a parent is entitled to Working Tax Credit run on, paid for 4 weeks period immediately after their employment ceases, or after they start to work less than 16 hours per week, their children may be entitled to free school lunches

- The Guaranteed Element of State Pension Credit
- Universal Credit

You are reminded that:

- registering is confidential
- taking up the meal is recommended but not compulsory
- a child may also receive additional help as a result of being registered e.g. with the cost of music lessons, school trips and other specific activity that the headteacher or governors may determine is reasonable in the circumstances.

Information you will need to provide

You may not need to provide proof of benefit as the Department for Education (DFE) has provided the local authorities with an online free school meals (FSM) eligibility checking service (ECS); this allows the Borough to verify if parents/carers registering for FSM meet the eligibility criteria entitlement. Please complete the attached form which will enable your eligibility to be checked. Please note this service is only used for checking free school meals eligibility as part of the free school meals registration process.

Should further proofs be required the Redbridge Awards & Support Team will write to you to request proof of benefit received as listed above.
