- information required for the processing of DBS application

WHY WE COLLECT AND USE GOVERNOR INFORMATION

The personal data collected is essential, in order for the school to fulfil its official functions and meet legal requirements.

We collect and use governor information, in order to meet the statutory duties placed upon us (this being the legal basis of **Legal Obligation** that we rely on for processing personal information for general purposes under GDPR).

All maintained school governing bodies, under <u>section 538 of the Education Act 1996</u> and academy trusts, under the <u>Academies Financial Handbook</u> have a legal duty to provide the governance information as detailed above.

In addition, concerning any special category data:

• 9 (g) processing is necessary for reasons of substantial public interest, on the basis of Union or Member State law which shall be proportionate to the aim pursued, respect the essence of the right to data protection and provide for suitable and specific measures to safeguard the fundamental rights and the interests of the data subject;

COLLECTING GOVERNOR INFORMATION

Governor data is essential for the school's operational use. Whilst the majority of personal information you provide to us is mandatory, some of it may be requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

<u>CCTV</u>

Our school uses Closed Circuit Television cameras for the purposes of monitoring our premises. There are visible signs showing that CCTV is in operation and images from this system are securely stored for 30 days where only a limited number of authorised persons may have access to them. We may be required to disclose CCTV images to authorised third parties such as the police to assist with crime prevention or at the behest of a court order.
